Bob asked if the USACE could be called to alert them of our issue.

### Airport:

The Middle Bass Airport drainage project is complete, new airfield signage has been installed and the permanent tie-downs were installed. The fence around the parking lot was not completed and it will be done in the Spring of 2023.
